## Roles and Responsibilities

### 1. MCT Training College Responsibilities:

Ensure compliance with all legal obligations regarding data privacy and sharing.

### 2. Malappuram District Police Office Responsibilities:

Deliver educational programs and materials as agreed upon with the institution.

Designate a liaison officer to serve as the primary point of contact with the institution.

Respond promptly to requests for assistance in emergency situations.
